Miriam and Rosbel Rodriguez came to Spaulding for Children in 2011, via a friend's recommendation, looking to provide a loving and supportive home for children. Miriam tried multiple methods, but was unable to get pregnant and thus came to Spaulding for Children looking to adopt.

Evelyn, now age 7, was placed in their home when she was just 3 years old, Adrian, now 3, was placed in their home when he was 1 month old. Evelyn and Adrian were placed with the Rodriguez family at the same time. Several months later their birth mother found out she was pregnant again and Ebony, now 2, was also placed in the Rodriguez home when she was just 14 days old. **Once these siblings arrived in the Rodriguez's home, the family was very interested in adopting all three children so Evelyn, Adrian and Ebony could grow up together.**

Over the next several years, the Rodriguezes walked the journey of going from foster parents to adoptive parents. The ups and downs. The struggles and victories. The rollercoaster of emotions that comes along with the process. **Although many unpredictable obstacles stood in their way throughout their journey to adoption, the Rodriguezes persevered and officially became a family in March.** The week before the adoption finalization, Miriam and Rosbel purchased a book to read to the children about adoption. They wanted them to feel comfortable and help them understand what their finalization would be like, so they would not be scared or confused.

The Rodriguezes are very excited to be a family now and cannot wait to plan a trip to take Evelyn, Adrian and Ebony to Mexico this year to meet the rest of their family!

Post Adoption in Fort Bend:

Each year, Spaulding for Children continues building community resources for adoptive families through our Post Adoption Program. Post adoptive support services allow our experienced staff to work with families on a personal level to help them connect as a family, provide learning opportunities and even coordinate support groups that allow members of adoptive families to talk about the joys and hardships that come with raising a child a that has experienced trauma as a result of past abuse or neglect.

Over the past several years, our Post Adoption Program staff noticed an increase in calls coming in from adoptive families in Fort Bend County requesting access to our post adoption support services. **After additional research, we discovered that the number of adoptive families in Fort Bend County have increased more than 25% since 2009; however, the services for these families have not increased at the same rate.**

At the end of 2014, Spaulding for Children received generous funding from The George Foundation to expand our post adoption services in Fort Bend County. Thanks to The George Foundation grant, we were able to hire Kristina Wyatt, who serves as our Post Adoption Resource Development Specialist in Fort Bend County. In this role, Kristina will identify and develop adoptive support services in Fort Bend County, connect post adoptive families to those services and serve families in donated space in the United Way Fort Bend Service Center. Spaulding for Children will also offer general client intake and case management services through this exciting program expansion in Fort Bend County.

We are immensely grateful to The George Foundation for their commitment to ensuring that adoptive families in Fort Bend County have access to high-quality adoption support services and look forward to expanding our work with adoptive children and families within Fort Bend County!
